

## Membership Dues: \$7,500

## Due Upon Receipt

**Membership:** Your membership in GJ grants you the privilege to use the Galactic Jungle (GJ) camp equipment and services, and participate in GJ camp sponsored activities, programs and events (collectively referred to as the "Camp Facilities") offered from time to time by GJ. GJ reserves the absolute right without notice to add, change or eliminate any Camp Facilities and to change its hours of operation. Membership dues and the suspension and termination of members are in GJ's sole discretion.

## Terms and Conditions:

**Ownership:** Membership is non-transferable and non-refundable. Your membership does not entitle you to any interest or ownership in GJ or its property and confers no right to participate in the management or operation of the Camp Facilities.

**Term:** Your membership term starts on the date you complete the Agreement and pay your membership dues. Your membership term ends December 31, 2022. This Agreement is non-renewable.

**Use of UFO Boards, Bicycles, Scooters and Zorbs:** UFO Boards, bicycles, scooters and zorbs MUST be signed out prior to each use. Only licensed drivers over the age of 18 may operate the UFO Boards. You must adhere to all rules and regulations, as set forth herein and in any posted instructions.

**Code of Conduct:** You agree to abide by the rules and regulations of GJ and Burning Man, including, without limitation, the Waiver, Release and Confidentiality Form attached hereto. Any member, and their guests, may be expelled from the Camp Facilities by GJ management for violation of any rule or regulation of GJ or Burning Man or for conduct which in the opinion of GJ management is detrimental to the welfare, safety and character of GJ.

**Damage or Injury to Person or Property:** You agree to pay for any damage to the Camp Facilities, or for injuries you cause to any person.

Fees and Charges: You understand and agree that you are responsible for payment of the Membership Dues set forth above.

**Cancellation:** A breach of any of the terms and conditions of this Agreement will result in the cancellation of your rights and privileges without any reimbursement of any kind. Should you wish to cancel this Agreement prior to the expiration of your membership term for any reason whatsoever, there will be no refund, partial or otherwise, on the dues paid.

**Early Termination:** In the event GJ decides to terminate your membership prior to the stated end of your membership term, such termination will be effective upon 15 days' written notice to you.

**Notice:** You agree that GJ may contact you regarding GJ and membership related information at the phone number and/or email address provided above.

**Miscellaneous:** In case any one or more of the provisions contained in this Agreement shall for any reason be held invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provision, and this Agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained herein. This Agreement embodies the entire agreement and understanding of the parties relating to the subject matter hereof, is non-assignable, may not be amended except in writing signed by both parties, and supersedes any prior representations,

agreements, and understandings, oral or written, if any, relating to such subject matter. This agreement shall be governed by the laws of the State of Nevada without regard to conflict of law rules.

By signing, I acknowledge that I have read all pages of this Agreement, including attachments, understand the terms of this Agreement and attachments, and hereby agree to the terms and conditions contained therein and to abide by all GJ policies, rules and regulations.
